The actual number of Earned MSUs will equal the Target Achievable MSUs multiplied by the Stock Performance Multiplier but will in no event exceed 200% of the Target Achievable MSUs. The "Stock Performance Multiplier" means the quotient obtained by dividing (i) the closing price of the Issuer's common stock for the 10 consecutive trading days ending on (and including) the Closing Date by (ii) the closing price for the 10 consecutive trading days ending on (and including) the trading day immediately preceding the date of grant.
- 4. The Earned MSUs vest ratably on each of the first three anniversaries of the date of grant, subject to continued employment with the Issuer through each applicable vesting date. Earned MSUs are generally settled in shares promptly after the applicable vesting date.
